COVID-19 Assumption of Risk and Waiver and Release from Liability

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Blessed Trinity Shrine Retreat (BTSR) has put in place preventative measures to try to reduce the spread of COVID-19; however, BTSR cannot guarantee you, your child(ren), or guests, visitors, volunteers, or employees with whom you may interact will not become infected with COVID-19. Further, participation in activities in and/or on the property of BTSR could increase your or your child(ren)’s and your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my child(ren) and I may be exposed to or infected by COVID-19 while participating in activities at BTSR – in the facilities, or on the grounds - and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 at BTSR may result from the actions, omissions, or negligence of myself and/or others, including, but not limited to, BTSR employees, volunteers, and other guests and/or visitors and their families.

By signing this form, I voluntarily agree to assume all the foregoing risks, and accept sole responsibility for any injury, illness, disability or death to myself, or to myself and my child(ren), or damage, loss, claim, liability, or expense, of any kind, that I or I and my child(ren) may experience or incur in connection with my or my and my child(ren)’s participation in activities in and/or on the grounds of BTSR (“Claims”). On my behalf or on behalf of myself and my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless BTSR, the Missionary Servants of the Most Blessed Trinity (MSBT), its volunteers, agents, sponsors, council, managers, directors, affiliates, representatives, attorneys, licensees, successors and assigns, all current, former, and future agents, representatives, religious, employees, and related entities (collectively, “BTSR”) of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of BTSR, MSBT, its employees, volunteers, agents, sponsors, council, managers, directors, affiliates, representatives, attorneys, licensees, successors and assigns, and related entities, whether a COVID-19 infection occurs before, during, or after participation in any activity in and/or on the property of BTSR.
